Vendors are required to provide their own generator and cords. All cords must meet the state code for outdoor use and be rated SO. If applicable your unit must display a current and valid Minnesota State Board of Electricity inspection sticker.

Vendors may only sell approved products. Vendors agree to arrive in time to set up and be fully operational by, and until, the hours of operation listed above. Vendors agree to clean the immediate area around their booth.

Vendors are liable for items they sell and accept all liability for any loss by damage or theft sustained during the event.

The vendor agrees to the payment arrangement and understands payment is due at the close of the event.

Vendors will defend and hold harmless the City of Nowthen and staff, Nowthen Heritage Festival Committee, and volunteers from all claims.

The vendor has read and agrees with the above information. Lack of compliance with any requirements may result in rejection of the application, entry into the event or removal from. The vendor understands that the festival is held rain or shine and must be prepared for inclement weather conditions.
